Communiqué

This communiqué highlights key discussions and considerations from the NMHS Board meeting held on 28 May 2021 in the Noongar Season of Djeran at King Edward Memorial Hospital.

Djeran season sees the start of the cooler weather. During this period fishing continued and bulbs and seeds were collected for food.



Undiagnosed Diseases Program (UDP)

The Board received an inspiring presentation on the Undiagnosed Diseases Program within the Women's Health, Mental Health and Genetics Directorate, WNHS. It is a groundbreaking initiative that has made significant differences to the lives of young children, including Aboriginal children, in WA, often through repurposing existing low-cost drugs. Strong collaborations with the World Health Organization and regional leaders has been a key aspect of this program.

Clinical area Tours

Board members toured three clinical areas in KEMH with WNHS Executive. We could see how busy the clinics and wards were and we thank all staff for your sharing and feedback. The Board is keen to work with the WNHS Executive Team to address feedback around staff shortage, leave and rostering to support the clinical workforce and to engage and retain young graduates and clinicians.

NMHS Climate and Sustainability Program

The Board received an update on the NMHS Climate and Sustainability Program and to learn that staff have been engaged to contribute through a staff forum as well as a NMHS-wide survey. Having the meeting in KEMH, we reflected on the opportunity to make the new Women's and Newborns Hospital a green and sustainable one.

Board Committee Updates:

The Board reviewed the minutes of its Committees and were provided with a precis from each Chair as follows:

- People, Engagement and Culture Committee highlighted the ongoing work in the diversity space and the Minister for Health Your Voice in Health survey. It received a presentation from the WNHS Next 100 Program, which provided the breadth of people, engagement and culture activities taking place in WNHS.
- Safety, Quality and Consumer Engagement Committee The recent Emergency Department death of a child at PCH has

- COVID-19 Testing and Vaccination Clinics
- Addressing workforce shortage in face of increased activity
- Ensuring the staff in our Emergency Departments feel supported and have adequate clinical supervision
