Our Community and Our People: embedding our values

Reflections on consumer and staff feedback are a monthly focus for the Board, in addition to reflecting on NMHS's values. The stories offer valuable insights to help us understand the needs of consumers and their concerns, providing learning opportunities to improve and deliver excellent health care.

The Board considered the value of care and use of empathy when responding to individuals who have taken the time to share their experience. The Board acknowledged the plan for quality improvement initiatives to build the skills and understanding of staff who respond to consumer and carer complaints.

Presentations to the Board

The Board received an update on NMHS's climate and sustainability initiatives, noting it coincided with the world's hottest week on record. Achievements in leadership and waste were highlighted, notably the Ride for Life, which was hosted by the NMHS. The event, which saw Western Australia the first state in Australia to participate, raised awareness of climate change and impacts on health outcomes. In addition, approaches to identify and target areas to reduce greenhouse gas emissions across the organisation, consistent with the State Government's emissions legislated reduction target, were considered.

The Chief Executive Officer of Joondalup Health Campus, who hosted the meeting, outlined several strategies implemented in the Emergency Department that have resulted in a reduction in the number of hours of ambulance ramping.

The Board also heard from the Executive Director of the Health Consumers' Council who provided an overview of the organisation, its role in advocacy and opportunities for partnership and engagement with the NMHS.

The Committee received a presentation from the Revenue and Accounts Payable team and an update on capital and infrastructure projects underway across the organisation.

In addition, reports and discussions focussed on performance, activity, budget and staffing trends, including strategies to ensure financial sustainability.

People, Engagement and Culture Committee

The focus area for June was culture and engagement.

The Committee received a presentation from Mental Health Public Health Dental Services, and progress updates on nursing and midwifery workforce engagement strategies, and deployment of the new enterprise HR Plus solution.

In addition, reports about work health and safety compliance, industrial matters, the status of internal audits and strategic risks were reviewed.

Safety, Quality and Consumer Engagement Committee

The Committee received an engaging and inspiring presentation on innovative and consumer engagement initiatives to improve care for older adults, and a safety and quality update from the Mental Health Public Health and Dental Services.

The Committee discussed the importance of effective clinical governance and strong organisational culture in improving and delivering safe, high-quality health care.

The latest safety and quality performance reports were considered, with focus on infection prevention and surveillance.
