Next Board meeting

Chief Executive

This month's report included updates on:

- Enactment of the NMHS Demand Escalation Framework, which comprises a range of initiatives to improve patient flow.
- Activity and performance, including initiatives to address continuing high demand for Emergency Department, outpatient and renal dialysis services.
- Engagement activities with local, State, and national representatives as well as sites and services
- Highlights, risks, and areas of focus from each of the operational areas.

Board Committee updates

The minutes and a summary from each of our Board Committee meetings were provided by the respective Chairs.

Audit and Risk Committee

No meeting held in June.

Finance Committee

The Committee received a presentation from Sir Charles Gairdner Osborne Park Health Care Group (SCGOPHCG) about its performance and activity, as well as an update on progress of the NMHS Business Improvement Strategy initiatives from the Executive Director Consumer Experience and Clinical Excellence.

The Committee considered reports on performance, activity, budget and staffing trends, including strategies to ensure financial sustainability. In addition, the status of priority procurements and contracts, and major capital works across the NMHS were reviewed.

People, Engagement and Culture Committee

The focus of the meeting was Culture and Engagement and included a briefing by the Area Director of Clinical Services on the Junior Medical Officer Manifesto, which has been highly successful in improving workplace conditions for junior medical staff, such that the NMHS has been recognised as an employer of choice for two years in a row.

The Committee also received a progress update on initiatives to make NMHS the Best Place to Work.

Reports about work health and safety compliance, industrial matters, the status of strategic risks were also reviewed.

Safety, Quality and Consumer Engagement Committee

The Committee heard from the Youth Detention Neurodevelopmental and Mental Health Service Project team, which supports vulnerable youths in detention.

The Committee discussed several continuous improvement initiatives, which use predictive analytics to drive better health outcomes for patients.

The monthly consumer experience, safety and quality performance and trends, with focus on activities to improve patient safety, were also reviewed.
