Our Community and Our People: embedding our values

Reflections on consumer feedback, as they relate to NMHS's values, are a monthly focus for the Board. The stories offer valuable insights to help us understand the needs and concerns of our community and provide learning opportunities to improve and deliver excellent health care.

The Board heard about a consumer experience, which highlighted the importance of informed consent and challenges of balancing the benefits of medical treatment with potential side effects. In response the Board reflected on potential initiatives to improve patient education and service delivery. Separately, the Board acknowledged positive feedback about person-centred care provided by Emergency Department nursing staff.

Presentations to the Board

The Medical Director of the WA Virtual Emergency Department (WAVED) and Lead of System Flow and Reform briefed the Board on the WAVED service, which was launched in September 2023. Members heard how a multi-disciplinary team works alongside St John Ambulance to deliver emergency care virtually, where safe and appropriate to do so, and connect patients with alternate clinically appropriate care options. The service, which has been piloting models of care for older adults living in residential aged care homes, has recently been expanded to include patients with mental health conditions. The Board acknowledged the Geriatric Acute and Rehabilitation Medicine team for its strong commitment to revolutionising the way care is provided to our elderly population to ensure the best outcomes.

Board Committee updates

The minutes and a précis from each of our Board Committee meetings were provided by the respective Chairs.

Audit and Risk Committee

No meeting held in April.

Finance Committee

The Committee received a presentation from Mental Health Public Health Dental Services about performance and activity, as well as updates on continuous improvement initiatives being delivered by the Strategy and Transformation Team.

The Committee considered reports on performance, activity, budget and staffing trends, including strategies to ensure financial sustainability. In addition, Climate and sustainability activities were reviewed.

People, Engagement and Culture Committee

The focus of the meeting was on work health and safety and included briefings on changes to WA workers' compensation laws and conversion of public health system senior medical practitioners to permanent employment under Commissioner's Instruction 42.

The Committee received a presentation on engagement, culture and wellbeing activities from Mental Health Public Health Dental Services and progress of initiatives to make NMHS the Best Place to Work.

Reports about work health and safety compliance, industrial matters, the status of strategic risks were also reviewed.

Safety, Quality and Consumer Engagement Committee

The Committee heard from the Midwifery Group Practice, which provides ante- and post-natal care for at-risk women.

The Committee considered the results of several diagnostic studies designed to contribute to practice improvements and improve health outcomes for patients.

The monthly consumer experience, safety and quality performance and trends, with focus on activities to improve patient safety, were also reviewed.
