- SCGH ENT Consultant Dr Jafri Kuthubutheen completed ground breaking surgery featuring new auditory brain implants that are helping people hear again. His team's work resulted in extensive local and national media coverage.
- NET launched the NMHS Aboriginal Health and Wellbeing Strategy 2022-2025: Listening and Doing. These practical priorities will guide our action over the next three years:
 - Cultural security for Aboriginal people;
 - Improving our services so that Aboriginal people feel culturally secure using them;
 - Engagement with Aboriginal people
 - Listening to, and acting on, what Aboriginal people are telling us
 - Strengthening our Aboriginal workforce: having more Aboriginal people join us to help

Work Health Safety (WHS) Act – an update and due diligence training:

Dr Kim McLean, Director Work Health and Safety for NMHS provided the Board with an update covering the following key issues –

- WHS Act 2020 main differences from the OSH Act
- Due Diligence what it is and how it impacts the Board
- NMHS Actions for compliance
- Immediate priorities.

Board Chair and Chief Executive update:

Updates and discussion focused on welcoming Dr Shirley Bowen as the Chief Executive of NMHS; review of current issues – COVID, demand in system, focus on Ambulance Ramping, Outpatient Reform, Safety & Quality concerns and the changes in the North Executive Team positions after resignations from Janet Zagari, ED SCGOPHCG and Stuart Windsor, ED PICM.

Board Committee Updates:

The minutes of each of our Committees were provided with a precis provided by each of the Committee Chairs:

- People Engagement and Culture
- Audit & Risk
- Safety, Quality and Consumer Engagement Committee
- Finance Committee.

These reports continue to highlight the work of the Committees and the level of demand, ongoing staffing, and budget pressures that NMHS is managing while working to maintain safe, high quality clinical care.

- The Strategy is a key component of NET Operational Initiative 4 – Kaya Wanju – Aboriginal people matter: Making NMHS services places where Aboriginal people feel safe, heard and important and where cultural needs are met.
- NMHS is the first health service provide to secure an Electric Vehicle fleet, initially based at Graylands Hospital and will be extended over time.
- KEMH is one of two hospitals in Australia to take part in the EPIC (Engagement in Plastic-free Innovation for Change) program aimed at reducing the health industry's significant contribution to plastic waste.
