Our Community and Our People: embedding our values

Reflections on consumer feedback, as they relate to NMHS's values, are a monthly focus for the Board. The stories offer valuable insights to help us understand the needs of our community and provide learning opportunities to make our services better and safer, to deliver excellent health care.

This month, the Board heard from a carer who was concerned about care provided to a family member while they were in hospital. In recognising the complexities and challenges of providing services to persons with mental health conditions, the Board acknowledged appropriateness of care and compassion displayed in responses to the complaint.

In addition, the Board recognised the positive experience of a consumer who received care from the multi-disciplinary healthcare teams at Osborne Lodge.

Presentations to the Board

The Board welcomed three internationally recognised clinical researchers from Sir Charles Gairdner Hospital whose exceptional contributions to medical innovation are tackling real-world problems in health to deliver societal impact and shape best practice.

Clinical Professors Shirley Jansen, Gary Lee and Chan Cheah showcased their clinical trial programs and therapeutic interventions, which are improving patient experience and health outcomes, as well reducing costs. In addition, insights on their innovation journeys were shared. The inspiring session also looked at enablers of, and barriers to, creating and embedding a culture of research and innovation across the organisation.

Separately, the Board received a progress update from the Strategy and Transformation team on development of key stakeholder maps, which will support effective and enduring Board engagement, decision-making and governance activities.

Next Board meeting

Board Committee updates

The minutes and a summary from each of our Board Committee meetings were provided by the respective Chairs.

Audit and Risk Committee

No meeting held in January.

Finance Committee

The Committee undertook an in-depth review into the organisation's financial health. Other discussions considered reports on performance, activity, budget, and staffing trends, as well as strategies to ensure financial sustainability.

In addition, the status of priority procurements and contracts, and major capital works were noted.

People, Engagement and Culture Committee

The focus area for December was Integrity. The briefing outlined initiatives that have strengthened integrity and improved transparency of decision-making resulting in improvements in workplace culture and capability.

In addition, the Committee received an update from the Executive Director of Mental Health about culture, engagement, and well-being activities underway across the service.

Performance and compliance reports for work health and safety, staff wellbeing, as well as industrial and operational matters were also reviewed.

Safety, Quality and Consumer Engagement Committee

The Committee welcomed representatives from Joondalup Health Campus who provided an update on progress of implementing recommendations from two safety and quality reviews. The work supports a positive safety culture by fostering safe and reliable care, reducing preventable incidents, and improving patient experience and outcomes.

The Committee also reviewed the organisation's clinical performance compared to peers in several recently published internal and external clinical quality registry reports, using evidence to improve the quality of health care we provide.

The monthly consumer experience, safety and quality performance and trends were reviewed, with focus on initiatives related to continuous improvement, quality assurance and embedding a safety culture.
